#### U.S. Secretary of Health and Human Services Lauds Montefiore's Innovative Approach to Care

n March 12, top-ranking national and state health officials, including Sylvia Mathews Burwell, Secretary of the U.S. Department of Health and Human Services (HHS), visited Montefiore Medical Group's Bronx East site to experience firsthand the health system's trailblazing approach to care.

Secretary Burwell, who was joined by New York State Deputy
Secretary for Health Courtney Burke and State Medicaid Director Jason
Helgerson, chose to visit Montefiore to reinforce HHS's commitment
to move Medicare payments into progressive payment models, such as
Montefiore's Pioneer ACO, and to tie Medicare payments to quality—not
quantity—of care. For nearly two decades, Montefiore has championed
an integrated approach to care and reimbursement. Secretary Burwell
lauded Montefiore's leadership in charting the future course of

healthcare, as well as the health system's success in meeting quality and affordability goals.

During the visit, longtime Montefiore patient Jim Pellicone, a Medicare beneficiary in the Pioneer ACO Program, told the audience that he wasn't aware until that day that he was in a "special program." His longtime physician, Donald Raum, MD, Regional Director, Montefiore Medical Group, and Assistant Professor, Medicine, Einstein, was one of Montefiore's first physicians involved in managing the health of patients through innovative patient models. Mr. Pellicone remarked on the excellent care that he and his wife received, while noting with amazement on the coordinated care that his doctors and nurses provided.

Secretary Burwell praised Montefiore for its imagination, in leading the way for New York, as well as the nation overall.

## Montefiore Associates Prepare for Greater Patient Care Integration

Montefiore leadership and the Epic@Montefiore project team are providing extensive support and resources to ensure that associates are prepared to engage with patients using Epic@Montefiore, a fully integrated electronic medical record system. Patient information will be centralized, so that providers at different locations can access both inpatient and outpatient records once the system goes fully live throughout the organization. More than 3,000 associates at Montefiore Medical Group, Occupational Health Services and CMO, Montefiore Care Management sites will be fully trained on Epic@Montefiore prior to the first go-live in May. In addition to requisite classroom training, associates who were trained previously will receive refresher training. Additional training includes use of the Epic "Playground," which provides realistic patient care simulations for associates to practice their new skillsets.

Epic@Montefiore underscores Montefiore's goals of providing patient-centered, high-quality care by enabling associates to provide patients with improved care delivery and an exceptional healthcare experience.

#### Patient Privacy and Texting on Your Cell Phone— Your Cell Phone Is Not HIPAA-Compliant

When using a cell phone or mobile device at Montefiore, you are not permitted to text protected health information. While texting is fast and convenient, it is not permitted under Montefiore's policies because it is not HIPAA-compliant, unless the text is encrypted, both while it appears on the phone and during transmission. Montefiore is piloting a secure texting app that, once launched, will allow encrypted texts to be sent from provider to provider. For now, however, this form of communication is not allowed.

Helpful guidance was published by the Office of Civil Rights and the Office of the National Coordinator for Health Information Technology of the U.S. Department of Health and Human Services on protecting patient privacy when using your mobile device. The information outlined in this initiative offers practical tips on how to protect patients' confidential health information when using mobile devices. Please note that The Joint Commission does not permit providers to text orders for patients. In addition to privacy concerns, texting orders provide no ability to verify the identity of the person sending the text. There is also no way to keep the original message as validation of what has been entered into the medical record.
